The role played by the Genoa Port Authority in the context of the European co-funded projects

To enhance the strategic position of the Genoa port as the main gate to Europe via the Corridor 24 for the traffic of goods transported in the Mediterranean

To make up a unique multimodal Corridor from Northern to Southern Europe by extending the Corridor 24 to the sea and connecting it to the Mediterranean Southern Range via the Genoa port

To reinforce the link between infrastructures and services along the Corridor 24 and its extension to the sea by meeting the needs and requirements of the transport market and by increasing the benefits for the territory

To support the evolution of Port Authorities and Institutions towards a more effective coordination of national and European logistics platforms

MoS 24 is included in a complex and evolving legal environment involving Italian Port Authorities:


- ✓ Art. 46 of the Law 2011/214 dealing with the integrated logistics systems
- ✓ Art. 62 of the Law 2012/27 regarding the completion of the Italian Logistic Platform
- ✓ Bill on the "Framework law on inland terminals and territorial logistics platforms" (Disegno di legge A.S. n. 3257 "Legge quadro in materia di interporti e di piattaforme logistiche territoriali")
- ✓ Art. 6 of the Law 1994/84 with reference to the PAs competences in the field of the promotion and development of intermodality, logistics and transport networks
- ✓ Directive 2010/65/EU dealing with Reporting Formalities






The Italian gate to Europe


- Southern-Central Italy logistic platform

Details about Activities 2 and 3 – Goals

Activities 2 and 3 include:

- ✓ The design of the intermodal web platform with the existing ICT systems along Corridor 24 and the related MoS services
- ✓ The implementation of the demonstrator of the planned platform
- ✓ The integration of the operational platform in a real context
 - ➤ the application will be made **on one/two concrete case/s** of Motorways of the Sea link (existing regular shipping link) from the Port of Genoa and/or other ports thanks to the **active involvement of the Stakeholders**
 - > the MoS shipping lines to test the Demonstrator have already been selected
 - ➤ the application will be made available to **all the operators interested**, without any distinction






Continuity of the Action

- ✓ The Preliminary Masterplan (and the related Business Model):
 - will offer a comprehensive view for further implementation through the creation of a Consortium among various stakeholders and users for the management of the ICT platform, taking thus into account the possible revenues derived from this activity
 - will target the new services to offer and the other logistics nodes to be included in the ICT network
- ✓ The creation of a concrete operational context in which insert the Demonstrator services and the promotion of a revenues policy will pave the conditions for the continuity of the Action's results after 2013




